## Moon Lake rancher notifies STF that he wants out of a Wildlife Extension Agreement

In early April, Jim V. and I were feeling really good about the completion of three water control structures, which were checking the downcutting of the Calamus in a valley. We had discussed the project with the neighbors and had their support. The structures were

installed about a week before the last heavy snowfall. The snowmelt created shallow wetlands just as planned.

The project took a turn for the worse when the landowner decided (within one week of completion) that he wanted to modify one structure so it would hold more water. The downstream neighbor immediately notified me and I contacted the owner and got his word he would remove the modification the following morning. By the next morning he had re-thought his decision and called and notified me that he was going to cancel the agreement and reimburse the STF for their expense. He asked me to send him a bill. I did so immediately. The following day the modified structure washed out while the other two remained intact. To date, I have not received payment for the three structures.

### **Easement guidelines established by the Sandhills Task Force**

At the last meeting, the Board approved the establishment of easement guidelines. These guidelines would serve the Task Force and also help the public understand where our organization stood on easement acquisition. The guidelines are posted on our website.

### **Task Force joined with Agren, Inc to submit a Conservation Innovation grant application.**

Several board members (Mike, A.B., Rob, and I) along with Jim V. and Al Steuter and others met with Stan Buman from Agren, Inc. to talk about the potential use of The Grazing Manager software within the Sandhills. Through the course of discussion, we encouraged Agren, Inc. to submit a grant application to NRCS' Conservation Innovation Grant. The grant identifies the Sandhills Task Force as a cosponsor of the grant. We, however, informed Agren that we did not have the authority to approve the concept or grant application. That would be a decision of the Board at the May meeting.

The overall goal of the project is to improve rangeland health and sustain profitable ranching by implementing and evaluating the use of *The Grazing Manager* software and supporting long-term use of sound grazing systems. It would be especially useful with planning for drought conditions.

If funded, the project would involve a combination of computer software, in-field training, rancher discussion groups, ranch visits, and one-on-one technical assistance.

The grant is being submitted for \$150,000. The target is enrolling 24 ranches that would use the software and develop a mentoring-support group. It is a 50:50 match grant with \$75,000 coming from ranchers and the Sandhills Task Force. Half of the \$75,000 would be in-kind match, which includes ranchers' time in participating in the program. The other \$37,500 would come from ranch tuition costs and STF. The STF would contribute \$375 toward each ranch participating (total of \$9000). An additional \$19,500 of Jim's salary would meet STF's cash match. The portion of the grant that would be paid to STF for their assistance would be \$29,000. Every dollar of Jim's salary spent on helping ranchers involved in this project would be matched with one grant dollar. It would reduce STF's salary expense by 50 percent.

### **Invasive weed control grant being proposed.**

Nebraska Grazing Lands Coalition is in the process of writing a grant to see if they can get some of the invasive species grant money that is available now. They plan on targeting leafy spurge in the Upper Loup NRD extending over to Loup, Garfield and into Custer counties. The money may also be available for cedar control. The Coalition contacted Jim V. asking if the STF would be willing to provide matching funds. Their request was made in the middle of March and we have not received any additional information since.

### **Mary Harding is asking for STF assistance with forming grassroots organizations.**

At our September 2005 board meeting, Mary asked the board if they would support a NET grant that would help other local groups organize similar to what the STF did. The extent of our involvement was to have board members meet with local groups and explain how the STF was formed and the lessons learned. That grant was approved and Mary is making plans to begin helping groups. She asked me recently if the STF would be willing to administer the financial portion of the grant. I told her I would be willing to do that but needed the concurrence of the Board.

### **Request received to provide funds for Sandhills Academy.**

In late February, I received a written request asking the STF to help fund the June 13-16 Sandhills Academy Camp. They are asking our group to fund \$2,500 for partial tuition for 20 participants. The description used in their advertising follows.

*"Feel the freedom and experience Sandhills Academy! Let this premiere natural resources and leadership camp help you explore the best of Nebraska's Good Life. Two days and one nights of this awesome experience are dedicated to exploring Cherry County and Ranches in Blaine County in the heart of the Sandhills. On this road trip, you'll discover wide-open spaces, unique traditions and incredible natural landscapes. Tube the Middle Loup River and camp at the Merritt Reservoir with a visit to Snake Falls. Visit the Gudmundsen Sandhills Laboratory, Bowring Historical Ranch, Bestol Ranch, and Cox Feeders. A trip to Diamond Lazy J Ranch (Sandhills Spirit of the West) with a chuck wagon dinner, horse-drawn wagon tour and fiddles around the campfire. And take part in the Sandhills Olympics on the beach at Merritt Reservoir. As they say.. Nebraska the good LIFE!!!!!"*
